A right of access to the personal information we hold about you;

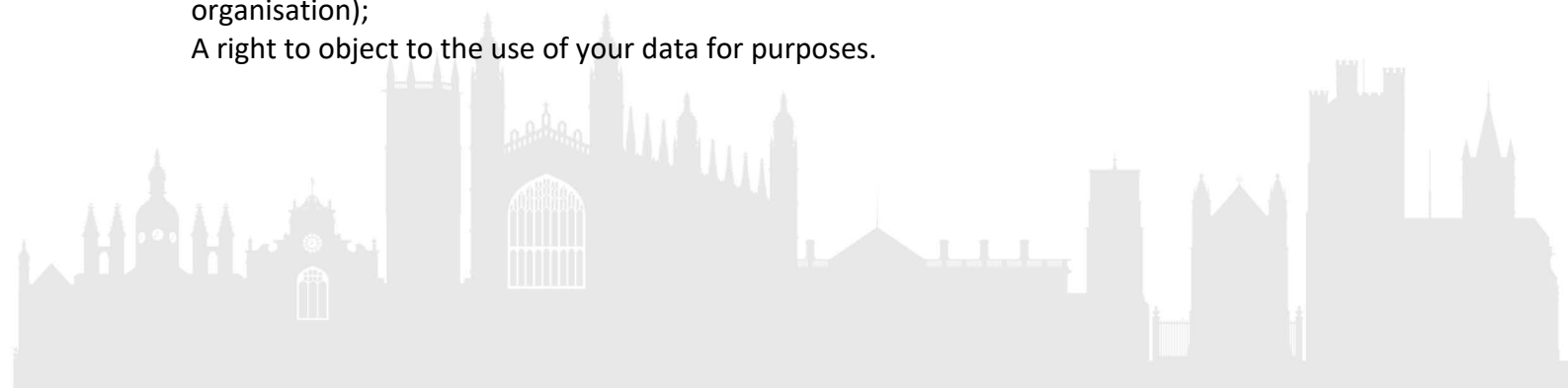
A right to rectification if any personal information we hold about you is inaccurate or incomplete;
